NOTICE is hereby given that the 98th Annual General Meeting (AGM) of the Company will be held on Thursday, 21st June, 2018 at 11.00 a.m. at M. C. Ghia Hall, Bhogilal Hargovindas Building, 4th Floor, 18/20, Kaikhushru Dubash Marg, Behind Prince of Wales Museum, Kala Ghoda, Mumbai 400 001.

The physical copy of the Annual Report including the Notice convening the AGM has been posted to the members. The soft copy of the Annual Report including the Notice convening the AGM has been sent by e-mail to those members who have registered their e-mail IDs with the Company / Depository Participant(s) for communication purposes. The Annual Report including Notice of 98th AGM of the Company is available on the website of the Company and also available for inspection at the registered office of the Company during office hours on working days, except Saturday.

In compliance with Section 108 of the Companies Act, 2013, read with Rule 20 of the Companies (Management and Administration) Amendment Rules, 2015, and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is pleased to provide its Shareholders with facility of "remote e-voting" (e-voting from a place other than venue of the AGM), through E-Voting Services provided by Central Depository Services (India) Limited (CDSL), to enable them to cast their votes at the 98th AGM.

In accordance with Rule 20 of the Companies (Management and Administration) Amendment Rules, 2015, the Company has fixed 14th June, 2018 as the "cut-off date" to determine the eligibility to vote by electronic means or in the general meeting. A person whose name is recorded in the register of members or in the register of beneficial owners maintained by the depositories as on the cut-off date, i.e. 14th June, 2018, shall be entitled to avail the facility of remote e-voting or voting in the general meeting.

The remote e-voting period begins on Sunday, 17th June, 2018 at 9.00 a.m. and ends on Wednesday, 20th June, 2018 at 5.00 p.m. During this period the eligible shareholders of the Company, holding shares either in physical form or in dematerialized form, may cast their vote electronically. The e-voting module shall be disabled by CDSL for voting thereafter.

The facility for voting, either through electronic voting system or ballot/polling paper shall also be made available at the venue of the AGM. The members who have already cast their vote by remote e-voting prior to the meeting may also attend the meeting but shall not be entitled to cast their vote again at the AGM.
